केरल में अवैध रोपवे को ध्वस्त करने का

मलाप्पुरम (केरल), 11 फरवरी (भाषा)।

केरल के उत्तरी जिले मलाप्पुरम में चीनकन्नीपोयिल और कक्कडमपोयिल के बीच गैर कानूनी तरीके से नीलांबुर के विधायक पीवी अनवर के कथित तौर पर बनवाए गए रोपवे और टावर को ध्वस्त करने का काम शुक्रवार को शुरू हो गया। इस गैर कानूनी ढांचे के खिलाफ कानूनी लड़ाई कुछ साल पहले तब शुरू हुई, जब उर्गाट्टेरी ग्राम पंचायत ने ढांचे और रोपवे को ध्वस्त करने का फैसला किया। नीलांबुर निवासी एमपी विनोद की शिकायत पर कार्य करते हुए स्थानीय स्व सरकार संस्थान के लोकपाल केके दिनेशन ने ढांचे को गिराने का आदेश दिया।

उल्लेखनीय है कि निजी कंपनी जिसका सह मालिक अनवर और उनके ससुर को बताया जा रहा है, ने रोपवे का निर्माण किया था और इससे पहले नदी पर चेकडैम बनाया था। केरल उच्च न्यायालय ने मई, 2019 में चेकडैम को ध्वस्त करने का आदेश दिया था। पंचायत ने रेस्तरां और मनोरंजन पार्क बनाने की अनुमति दी थी, लेकिन विधायक ने कथित तौर पर अवैध रूप से जंगल के करीब 480

केरल में चेकडैम था। पंचायत ने कथित करीब

मीटर के रोपवे जिला प्रशासन को ध्वस्त करने के खिलाफ कानूनी लड़ाई लेकिन वह आधिकारिक तौर पर जिला प्रशासन को पहले तक दूरअसल, चर्चा में गठबंधन विधानसभा जाने के बाद मौजूद थे।
